



CM to review COVID-19 situation, no decision yet on increasing testing

The Hindu Bureau

Delhi Chief Minister Arvind Kejriwal has convened an urgent meeting of health and other senior officials on Thursday to take stock of the COVID-19 situation, following a directive by the Union Health Ministry asking States to bolster genome sequencing of CO-VID-19 samples.

"All COVID-19 positive samples with a CT value of less than 25 will be sent to the NCDC [National Centre for Disease Control] or ILBS [Institute of Liver and Biliary Sciences] for genome sequencing. We are keeping a close watch on

the situation, but there is no decision yet on increasing testing," a Delhi government official said.

On Tuesday, only seven new cases were reported in the city while 2,676 tests were done in 24 hours, according to an official bulletin. The COVID-19 positivity rate was recorded at 0.26% and there was no new death.

"In view of the spurt in positive cases, it is essential to gear up genome sequencing of positive case samples. Such an exercise will enable timely detection of newer variants, if any," Union Health Secretary Rajesh Bhushan had

Delhi to get ₹700 crore from Centre to repair its roads

The Union Ministry of Road Transport and Highways will provide ₹700 crore to Delhi from the Central Road Fund (CRF) for the construction, repair and maintenance, and beautification of roads in the national capital. The decision was taken by Union Minister Nitin Gadkari (in picture) at a meeting with Lieutenant-Governor V.K. Saxena on Wednesday, officials at the Raj Niwas said. Mr. Gadkari also directed NHAI to bear the cost of repairing and beautifying all its roads in the city.

Delhi govt. schools to introduce 'mini snack break'

The Delhi government's Directorate of Education has asked schools to incorporate a 10-minute snack break in the timetable, in addition to a lunch break. In a circular issued to schools under its jurisdiction, the department said the mini break should take place two-and-a-half hours before the lunch break. In a bid to combat widespread malnutrition among children, schools have been asked to prepare a weekly planner of snacks, offering three food choices every day which may include food items such as seasonal fruits, sprouts, salad, etc.

Delhi wakes up to foggy morning, low visibility

Fog cloaked Delhi on Wednesday morning, lowering visibility to 400 metres and affecting road and rail traffic. A Railways spokesperson said around 18 trains are running late by one-and-a-half to five hours. Operations at the Delhi airport remained normal, an official said. On Tuesday night, three flights were returned or diverted to the Delhi airport due to bad weather in Chandigarh, Varanasi and Lucknow, he said. The Safdarjung Observatory, the primary weather station in Delhi, recorded a minimum temperature of 7.1 degrees Celsius, a notch below normal. The maximum temperature is likely to settle at 22 degrees Celsius, the IMD said. PTI

Hoax bomb threat at IGI Airport leads to security drills

A social media chat about "bombing and eliminating" Delhi's IGI Airport led to a brief panic and triggered a counter-terrorist security drill at the country's largest civil aviation facility on Wednesday, official sources said. The threat was categorised as "non specific" or hoax around 6:30 a.m. after over an hour of conducting anti-sabotage checks at the facility even as normal passenger traffic continued, they said. Airport security officials, according to sources, were informed about a social media post, in reply to an another message, that the airport should be bombed. The chat posts, whose creators are being traced by the police, also talked about "eliminating" the airport, the sources said. PTI

"The only open spaces adjacent to the restaurants are corridors and parking lots, so it will cause crowding. This will only cause hindrance on days when footfall is high," said Atul Bhargava, president, New Delhi Traders' Association.

Viral video: police deny violence at prayer meet

Responding to claims made in a viral video. about a "church in Delhi being attacked" on the suspicion of forcible conversion, Delhi Police on Wednesday said that the event took place on Sunday at a private residence in Burari and no violence was reported in the area.

"An incident of protest took place outside private premises in the area. An adequate police force attended to the PCR call. No cognisable offence was made out and no conversion took place," DCP (North) Sagar Singh Kalsi said. "The house was used for meeting and singing carols between 10.30 a.m. and 12.30 p.m.," the DCP added.

A senior police officer said that the owner of the rented house, where the Sunday mass was being observed, made a PCR call, alleging that people were being converted to Christianity on the premises. The police have issued a notice to the social media user who shared the video of the incident.

A year on, students still waiting for bicycles; MCD says cost of project too high

Close to a year after the erstwhile South Delhi Municipal Corporation (SDMC) passed a proposal to distribute 3,000 cycles to Class 4 students in its schools, students are yet to receive

proposal passed in January, before the merger of the three erstwhile municipal corporations - North, South and East – in May.

The distribution of cycles was to begin in February, according to the then standing committee chairperson B.K. Oberoi (BJP).

The execution was delaved multiple times over the following months, as senior MCD officials claimed that the tendering process had not been concluded.

In August, senior officials at the Municipal Corporation of Delhi (MCD) said that the proposal would not be limited to the schools run by the erstwhile SDMC, instead, the cycles would be distributed among students in the civic body-run schools across all the 12 MCD zones in the city.

While multiple delays have left the project in limbo, a senior MCD official said that the project has not been scrapped. But, he added, there is

no clarity over its timeline as of now.

The official added that the civic body has floated tenders for the project yet again.

No clarity over timeline

"The cost of the entire proiect was found to be on the higher side. This is why the process had to be repeated. It will take some time. A deadline cannot be fixed right now," said the official.

After the proposal was passed in January, Mr. Oberoi had said that the decision to provide the cycles was aimed at "motivating the students to come to school regularly".

He had estimated the cost of the project to be around ₹90 lakh.



In the recently held MCD polls, the Aam Aadmi Party (AAP), with 134 seats, ousted the BJP, which was in power at the erstwhile civic body (now unified) for 15 years. The Congress secured nine seats while the independents won three.

"As of now, AAP's councillors are working towards cleaning the city. Soon, Delhi will move towards a big change," AAP MCD incharge Durgesh Pathak

"A total of 91.57 lakh beneficiary farmers, including bargadars (sharecroppers) will receive a total assistance of ₹2,555 crore for this season. During the Kharif season, ₹2,468 crore was disbursed to 89 lakh

farmers," a press statement from the State government said.

Under the revised 'Krishak Bandhu (Natun)' scheme, the financial assistance to farmers has been increased to ₹10,000 for cultivable lands of one acre and more, and proportionate amount for land area below one acre with a minimum of ₹4,000 per annum in two equal instalments. West Bengal is the only State that has not joined the Union government's 'PM-KISAN' scheme which provides cash endowments to farmers.

Drugs carrying drone shot by BSF, falls on Pakistan side

A Pakistan drone that reportedly dropped drugs into India along the International Border in Punjab was intercepted by BSF troops following which it fell on the other side, a senior officer said Wednesday. The drone was "downed" by Border Security Force (BSF) troops around 7.20 p.m. on Tuesday and it has been taken away by the Pakistan Rangers, he said. The incident took place near the Daoke border post in Amritsar. The drone was seen lying 20 metres inside the Pakistan territory opposite Indian border post Bharopal when the area was searched on Wednesday morning. PTI

Notice to actor Nagarjuna over 'illegal construction'

A panchayat in Goa on Wednesday issued a "stop work" notice to Telugu actor Nagarjuna over the alleged illegal construction and excavation work at Mandrem village in North Goa. Mandrem Panchayat sarpanch Amit Sawant has issued the notice under the Goa Panchayat Raj Act 1994. As per the notice, the respondent has been involved in alleged illegal activity in the village jurisdiction. The Panchayat warned of necessary action under the Goa Panchayat Raj Act if the work is not stopped immediately.

Morbi tragedy: HC issues notice to maintenance firm

The Gujarat High Court on Wednesday issued a notice to the company involved in the maintenance and operation of the Morbi suspension bridge, which collapsed in October killing 135 people, on a plea seeking the company be made a respondent in the suo motu proceedings initiated

by the High Court. A Division Bench of Chief Justice Aravind Kumar and Justice Ashutosh Shastri issued notice to Ajanta Manufacturing Limited on the plea which stated the "acts of malfeasance on its (the company's) part makes it liable for the payment of exemplary damages". The High Court said it had initiated suo motu proceedings after taking cognizance of news items on the death of 135 persons in the October

30 bridge collapse tragedy. The Bench also dismissed an application filed by 46 councillors of the Morbi municipality seeking they be impleaded in the proceedings as they fear the civic body might be superseded going by the observations made by the High

Court in its previous order. The next hearing will be held on January 19.

Kashmiris celebrate with *pherans* to beat freezing 40 days of *Chillai Kalan*

In a first, the beginning of the 40-day harshest spell of winter, locally called Chillai Kalan, was celebrated as Pheran day in the Kashmir Valley on Wednesday, to popularise the loose-and-long woollen gown worn to fight the biting cold as the minimum temperature hovers below zero degrees Celsius here.

Scores of youth wearing pherans cat-walked near the Ghanta Ghar in Srinagar's main commercial centre, Lal Chowk, "to promote wearing of pherans".

Pheran as identity

"The event is an attempt to showcase our culture. We wanted to convey that the *pheran* is our identity. We should wear it with pride," one of the organisers of the event said.

A special ramp show, in which scores of youth, including women, participat-

ed, was organised at the Sher-i-Kashmir International Convention Centre here by the Army.

"This event will send across a message of harmony and peace from J&K," said Nasir Khan, a city resident.

Hundreds of local people changed their display pictures on social media platforms to showcase the pheran.

Worn for centuries in the Kashmir Valley, the garment easily accommodates a *kangri*, a firepot used to keep the body warm.

A cold wave gripped the Valley on the first day of Chillai Kalan. According to the India Meteorological Department, the minimum temperature in Srinagar was minus-4.2 degrees Celsius.

The tourist favourite of Pahalgam recorded minus-6.2 degrees Celsius, while the minimum temperature in Gulmarg was minus-4.6 degree Celsius. A dry spell is also adding to the cold wave. Unlike in the past, there has been no spell of snowfall in the plains of the Kashmir Valley so far.

Ex-Mumbai police chief gets bail in graft case

A Delhi court on Wednesday granted bail to former Mumbai Police Commissioner Sanjay Pandey in a corruption case related to National Stock Exchange (NSE) co-location scam and alleged phone tapping of the bourse employees.

Special Judge Sunena Sharma granted the relief to Mr. Pandey, noting that he was already on bail from the High Court in a related money laundering case. The CBI had arrested him in September.

"Considering the fact that the High Court has already granted bail to the accused in the connected ED matter, which in the light of Section 45 PMLA embodies far more stringent conditions for grant of bail, I find no reason to decline bail to the applicant in present case," the judge

Calling himself the AIADMK's coordinator, he replied in the affirmative to a question on whether he would work along with the party's former interim general secretary V.K. Sasikala.

"We will cooperate with all those who stood by Puratchi Thalaivar [the party's founder M.G. Ramachandran] and Amma [Jayalalithaa]; those who had strengthened the party and who had protected the organisation in the last 50 years regardless of who they are," he said.

Answering the criticism that he was soft towards the ruling DMK regime, Mr. Panneerselvam said ever since the DMK came to power, he had been issuing statements daily, highlighting the shortcomings in the working of the State government. To a question on whether the BJP was seeking to "swallow" the AIADMK, Mr. Panneerselvam said "no one can swallow the AIADMK". The group's political advisor, Panruti S. Ramachandran, who was beside him during the interaction with the media, said "small fishes cannot eat a whale."

Earlier, addressing the meeting, the deposed coordinator launched a broadside against Mr. Palaniswami and called him a "dictator". Deploring the repeal of a provision in the party's by-laws that Jayalalithaa was the "eternal general secretary", Mr. Panneerselvam said the State would not "forgive the sinners", who were responsible for it.

May threw up a hung coun-


cil with the BJP emerging as the single-largest party with 12 of 25 seats. The MNF and the Congress bagged nine and four seats, respectively.

As "natural allies", the BJP and MNF were expected to form the alliance government in the council. But after more than three weeks of uncertainty, the MNF sprung a surprise by aligning with the Congress members to form the council on June 1. This government was toppled on November 25 after the three MNF members voted in favour of the BJP's noconfidence motion.

"We resigned on Tuesday as Zoramthanga failed to keep his promise of forming a coalition government with the BJP in the council," one of the three pro-BJP members said.

Raut, a Rajya Sabha MP. His remarks came in the wake of the Bommai government's stance to pass a resolution in the Karnataka Legislature "that not even an inch of land" would be given to Maharashtra.

Maharashtra Minister and Eknath Shinde faction leader Shambhuraj Desai warned that if Mr. Bommai did not refrain from making "irresponsible statements", then Maharashtra would have to rethink about supplying water from its dams to the neighbouring State.

"When the case is sub judice, a Chief Minister should not use threatening language," Mr. Desai said He warned that Mr. Bommai ought to keep in mind that Karnataka is dependent on water supply from the Koyna and Krishna dams during dry season of March and April.

Meanwhile in Bengaluru, Mr. Bommai took serious exception to Mr. Raut's statement that they would "attack Karnataka like China". The Chief Minister said he would take up the matter with Union Home Minister Amit Shah.

India's vaccination strategy should accommodate for SARS-CoV-2 changes

he spurt in coronavirus cases reported out of China has triggered global alarm. India's Health Ministry has issued a directive to States to send positive samples to the Indian SARS-CoV-2 Genomics Consortium (INSA-COG) to check for new, concerning strains. The Health Minister, too, has called for a review meeting of the coronavirus situation in India. India's official numbers suggest that, thus far, there is little to worry. There are only 3,408 active cases. Only one district has a test positivity rate of over 10% and only four between 5 and 10%, as per the latest available weekly data. India's COVID-19 vaccination coverage has exceeded 219.33 crore, and there are no signs of distress being reported out of hospitals. However, the experience of previous years is that it is usually many weeks after which a noticeable spike, let alone a wave, is confirmed by health authorities. There is scarce monitoring and mask mandates for public gatherings, airports and railway stations have been removed everywhere; so, low numbers do not necessarily mean new variants are not taking root.

In China, despite reports of crowded mortuaries, hospital admissions piling up and stockedout pharmacies, weekly death counts are officially in the single digits. The prevalent opinion is that the lifting of curbs, after almost three years of some of the most restrictive containment measures, has now exposed a large swathe of people who lack 'natural immunity'. Some mathematical modelling projections calculate a million CO-VID-19 cases in the coming days in China. Given that much of the world has moved to normalcy in terms of travel, the concern is that this surge is likely to reverberate globally with many more infections, even in India, inevitable. There are two key lessons that can be derived from the Chinese experience: long lockdowns cannot eliminate the virus or prevent the development of new strains, and the only reasonable defence possible against severe disease is via vaccines. China has largely depended on home-grown vaccines such as CoronaVac and Sinopharm vaccines that rely on the inactivated virus technology. Despite 90% of the population receiving a single dose, and half, a second dose, the numbers in China suggest that waning immunity is a fait accompli. The big lesson for India is to not only establish the prevalent coronavirus variants but also whether the administered vaccines continue to be efficacious. While most of the vaccines administered in India are Covishield, and thus of the spike protein, it may be time to accommodate for changes in the virus. The sequencing of strains by INSACOG should not remain an academic exercise.

Ties with Taliban

India must curtail Afghan engagement as long as the repressive regime exists

n its latest outrageous decision, the Taliban regime has announced a ban on female students studying in universities. The "cabinet" meeting decision is one in a series that wipes out the many societal gains since 2001, the last time the Taliban was in power. These decrees include banning Afghan schoolgirls from studying above grade six, job restrictions and a ban on women at gyms and public parks, with public floggings for those travelling without male relatives chaperoning them. In effect, a regime that is growing crueller and less rational by the day, wants about half the country's population out of public sight. Making the decision publicly and officially is the regime's way of thumbing its nose at the international community by reneging on promises made during the Doha talks, including establishing an "inclusive" government. The international community must now review its current policy towards the Taliban 2.0 regime. While no country recognises the Taliban officially, many openly engage with the regime leaders; more than a dozen, including India, have diplomatic missions. The Government has sought to explain its decision to go back into Afghanistan and to even meet with Ministers such as Sirajuddin Haqqani who were responsible for attacks and killings at Indian missions as pragmatic policy to ensure India's security and the smooth delivery of aid. In fact, these policies have only made it more comfortable for the Taliban to continue to rule, while giving shelter to terrorist organisations, including those that target India. In addition, New Delhi's decision to cancel all visas to Afghans, hurt female students seeking an education in India the most.

Instead of pleading helplessness, there is much that the global community can do, acknowledging that women's rights are at the core of the issue with the Taliban, and not just a "desirable" outcome that is optional in Afghanistan's future. It must curtail engagement with the Taliban, which depends on external assistance to run its government structures. Leading nations should also create platforms outside Afghanistan for non-Taliban Afghan leaders, particularly women who had been elected in the past, to regroup, organise and voice an alternative vision to the dark one the Taliban seems set at thrusting the country into. India, as a regional leader, must review its "hands-off" approach to the people of Afghanistan who have clearly suffered many deprivations in the past year. Lofty words at the United Nations Security Council and other international for a have done very little to alleviate those hardships, and even less to further India's interests or goodwill amongst a people that it has historically been seen as a good friend to.

The need to make cancer drugs affordable

he subject of the spiralling costs of cancer medicines and their implications that have frequently been highlighted the world over were dwelled on in a recent report ("Cancer Care Plan and Management") by the Rajya Sabha's Standing Committee on Health (bit.ly/3jfmxLG). Alluding to the implications of the high cost of cancer care, the Committee noted that "about 40% of cancer hospitalization cases are financed mainly through borrowings, sale of assets and contributions from friends and relatives". This situation has arisen, according to the Committee, because "even average out of pocket spending on cancer care is too high" and that "spending for cancer care in private facilities is about three times that of public facilities". The Committee has, thus, highlighted the seriousness of problems concerning the treatment of cancer, the estimated incidence of which in India was nearly 1.4 million in 2020.

Impact on survival rates

The catastrophic treatment cost has seriously impacted survival rates in developing countries. In breast cancer, while the five-year survival rates in India and South Africa are estimated to be 65% and 45%, respectively, in contrast, in high-income countries, it is nearly 90%. In its explanation of this dismal situation, a World Health Organization (WHO) report on pricing of cancer medicines and its impacts had stated that the cost of a course of standard treatment for early stage HER2 (human epidermal growth factor receptor) positive breast cancer would be equivalent to about 10 years of average annual wages in India and South Africa and 1.7 years in the United States (bit.ly/3v0iRQm).

According to WHO, the costs associated with other medical care and interventions (such as surgical interventions and radiotherapy) and supportive care would make overall care even more unaffordable.

In the treatment protocol for breast cancer, CDK (cyclin-dependent kinase) inhibitors constitute a major therapeutic tool, especially for metastatic breast cancer. Three drugs, Ribociclib, Palbociclib and Abemaciclib, belong to this therapeutic class, which help in slowing the spread of cancer cells in the body. A month's treatment using these drugs could range between ₹48,000 and ₹95,000 and the patient is expected to take one of these medicines for the rest of her

The justifications by pharma companies

Excessive costs of breast cancer medicines can be explained by the interplay of two related factors. The first is the argument advanced by the large pharmaceutical companies - that they spend over \$3 billion in bringing a new molecule to the market, which they must recoup in order to remain in the market for innovation. However, the WHO report mentioned above observed that spending on research and development may bear little or no relationship to how pharmaceutical companies set cancer medicine prices. Companies set prices with an eye to maximise profits, thus denying patients from taking advantage of medical breakthroughs.

A second factor that allows the companies to sustain their high profit margins is intellectual property protection. Over the past three decades, pharma companies in the developed world have successfully persuaded their governments to strengthen the rights that they derive from patents and other forms of intellectual property rights by which they can exercise monopoly control over their products. Moreover, the scope and the power of these monopolies can become nearly absolute due to several factors, of which two are as follows.

Ordinarily, patent rights over a medicine last until the expiry of its patent term, after which generic competition leads to a reduction in its price. However, in the case of several non-communicable diseases, including cancer, the situation could be quite different. Even before the generic producers enter the market, newer therapies could be introduced as standard care for treatment, replacing drugs of an earlier generation. Additionally, in the case of pharmaceutical patents, the leading firms in the industry often obtain patents on incremental innovations involving older medicines ("evergreening" of patents), thus extending their monopoly rights over the medicines.

The three breast cancer medicines mentioned above are currently under patent protection implying that Indian companies cannot manufacture these medicines without the consent of the right holders. Pfizer's patent rights on Palbociclib will expire in 2023, while Novartis' rights on Ribociclib and Elly Lilly's rights on Abemaciclib would expire between 2027 and 2029, respectively. Therefore, high prices on these medicines will continue at least until 2029, and possibly beyond, if these drugs are subjected to "evergreening".

The lack of access to these critical medicines has not only pushed the life of patients and their families into deep financial stress but it has also jeopardised their right to live with dignity, a fundamental right guaranteed under Article 21 of the Indian Constitution. The Supreme Court of India has interpreted right to life as the most precious human right, which forms the "ark of all other rights must therefore be interpreted in a broad and expansive spirit so as to invest it with significance and vitality which may endure for years to come and enhance the dignity of the individual and the worth of the human person" (bit.ly/3BKL6Gx). In this spirit, the Court has, in several judgments interpreted right to health as an extension of right to life under Article 21. Further, it must be mentioned that according to the WHO Constitution, "enjoyment of the highest attainable standard of health is one of the fundamental rights of every human being' (bit.ly/3WpSvDg).

A way out

Thus, when all aforementioned considerations demand that cancer medicines must be provided to the suffering at affordable prices, what are the options before the Government? The most obvious option is to authorise Indian companies to domestically produce high-priced cancer medicines, including those mentioned above, by granting compulsory licences (CLs) in keeping with Sections 84 and 92 of the Patents Act. The CLs override patent rights, enabling domestic companies to manufacture generic alternatives when prices of patented medicines are high. Alternatively, the Government can invoke provisions of Section 100, which empowers it to authorise any entity to use a patented invention without the authorisation of the patent holder. Section 100 can be useful if no domestic company shows interest in obtaining a CL for any of the cancer medicines mentioned above. In view of the concerns expressed by the Rajya Sabha's Standing Committee on Health regarding the high prices of cancer medicines, invoking the provisions of Section 100 seems to be the best way forward.

In the recently concluded WTO Ministerial conference, there was an agreement that the CLs can be used for increasing domestic production of COVID-19 vaccines and medicines by developing countries. When the present situation looks propitious for the granting of CLs, why is the Indian government stepping aside from using this instrument to promote the domestic production of cancer medicines, and making them affordable?

The 'invincible originality' of Srinivasa Ramanujan

was Shakespeare who said, "To hold as 'twere, the mirror up to nature".

The English computer scientist Alan Turing's "imitation game" or "Turing test" takes the stance that a machine successfully represents a human if it responds to a question like a human mind does. From Plato's mimesis (representation) as the principle of art, to the Turing test, and to recent progresses in artificial intelligence, "the key to artificial intelligence has always been the representation" (Jeff Hawkins).

Taking representation further, can a machine "create" new things? Latest advancements in technology have attempted to "create". The recent buzz around ChatGPT (Chat Generative Pre-trained Transformer), a software tool that can answer questions on almost any topic, carry on conversations with humans, write poems, computer programs and perform many more complex tasks that require intelligence, is testimony that artificial intelligence can "create". One can also mention here Google's product LaMDA (Language Model for Dialogue Applications) that is similar to ChatGPT and other sophisticated products (Dall E) that can create image from verbal descriptions. Broadly speaking, the products mentioned above learn to be creative from already existing information: human conversations and documents and pictures, to synthesise and create.

Research by a machine

Extending these capabilities, can a machine do research? In early 2021, a team of Israeli scientists announced a software tool called The Ramanujan Machine that creates mathematical conjectures which are equations without proof. Mathematicians then prove or disprove these conjectures, thereby establishing theorems. Conjectures in mathematics shed light on newer frontiers that otherwise lurk in tenebrous corners. Srinivasa Ramanujan was famous for such conjectures. From 1904 till his passing in

'Unparalleled ability'

How does the Ramanujan Machine imitate Ramanujan? To understand this, one may consider Ramanujan's formulae on π (22/7 is only an approximation to π). In 1914, Ramanujan published multiple formulae to compute using modular equation which is, roughly speaking, an equation in x that equals the same equation in powers of x, i.e., x^n ; the solutions of the equation were manipulated to yield the decimals of to astonishing accuracy. The mathematicians J.M. Borwein and P.B. Borwein who computed to great accuracy in the 1980s said, "Ramanujan was unparalleled in his ability".

However, the Ramanujan Machine adopts a different approach to compute formulae for mathematical constants such as π , e, etc. It does so by taking a mathematical structure such as a continuous fraction on one side of an equation and the mathematical constant such as π on the other side, with the two sides yet to be matched. The software then employs high computing power and algorithms to iteratively match both sides and a conjecture is discovered. In the last couple of years, dozens of conjectures have been

discovered this way. Is this advancement a pronouncement that Ramanujan's creativity was held high solely by the stanchions of his calculating speed and memory? Mathematicians aver that Ramanujan's intuition, as seen in his works, was non pareil; Ramanujan could connect different mathematical domains deeply with "invincible originality" (G.H. Hardy). The ramifications of such

connections between mathematical abstractions that Ramanujan was prescient of have continued to unravel for over a century now, leading to remarkable technological applications. For example, elliptic curves are widely studied in number theory because of their properties that have applications in cryptography which make computer network communications secure. Ramanujan's contributions here are significant: he developed certain equations called class invariants which generate elliptic curves suitable for encryption and this led to Elliptic Curve Cryptography, an efficient cryptographic technique, in 1985, many decades after his

A leap of genius

Another instance of his originality was his discovery of mock-theta functions, his swan song; working on it might have been a palliative to him in his painful last days. George Andrews, an American mathematician and an expert on mock theta function, elegantly surmised that Ramanujan might have discovered it by starting from hypergeometric series whose consecutive terms form ratios that follow a pattern. George Andrews adds that it is a plausible method to arrive at mock-theta functions "provided you had the genius to recognize".

In the light of such deep insights from Ramanujan, George Andrews remarked on the eponymous machine, "I expect its role to be that of an important auxiliary tool." Formulae involving fundamental constants such as π have been discovered only sporadically in mathematical history; and by making such discoveries automatic and more frequent, the machine can lead to more frequent mathematical advancements. In general, artificial intelligence tools are expected to make things happen faster because they now imitate cogitation.

As for Ramanujan, he is inimitable even in the age of artificial intelligence – as any genius is.

Benchmarks for ECs' appointments

he way India's constitutional and political structures have evolved over the years seems to have made elections almost a mechanistic and ritualistic exercise. The reason behind this is the setting up and functioning of the Election Commission of India (ECI). This has come into public discourse because of the hearings in the Supreme Court on the appointment of Election Commissioners (ECs).

While many issues related with the ECI have been discussed in court hearings and outside, a deeper look at the ECI may be useful, given its role in the preservation of democracy in the country.

Working of the Constitution

Article 324 of the Constitution is the fountainhead that creates the ECI. This brings to mind the larger issue of the working of the Constitution. For this, it is worth recalling what two stalwarts of Constitution-making (the President of the Constituent Assembly (CA) and the Chairman of the Drafting Committee for the Constitution) said in their final speeches in the CA when the Constitution was finally adopted.

While commending the adoption of the Constitution to the CA on November 25, 1949, Dr. B.R. Ambedkar said, "However good a Constitution may be, it is sure to turn out bad because those who are called to work it, happen to be a bad lot. However bad a Constitution may be, it may turn out to be good if those who are called to work it, happen to be a good lot. The working of a Constitution does not depend wholly upon the nature of the Constitution."

The next day, on November 26, 1949, almost echoing Dr. Ambedkar's words, Dr. Rajendra Prasad said, "Whatever the Constitution may or may not provide, the welfare of the country will depend upon the way in which the country is

administered. That will depend upon the men who administer it... If the people who are elected are capable and men of character and integrity, they would be able to make the best even of a defective Constitution. If they are lacking in these, the Constitution cannot help the country. After all, a Constitution, like a machine, is a lifeless thing. It acquires life because of the men who control it and operate it, and India needs today nothing more than a set of honest men who will have the interest of the country before

If we take the above-mentioned views of the two luminaries as a guide for choosing who should be assigned the task of ensuring that the roots of democracy are kept appropriately watered and nourished, the answer is Election Commissioners (ECs).

All the arguments and proposals mentioned during the court hearings will, obviously, be an improvement over the existing system of appointment of ECs but if we want ECs to match the qualities stated by Dr. Ambedkar and Dr. Prasad, then we need to go beyond how Article 324 of the Constitution and the Election Commission (Conditions of Service of Election Commissioners and Transaction of Business) Act, 1991, have been operationalised so

Elevation of EC to CEC

One major weakness in the system(s) of appointments of the ECs proposed so far is that they all perpetuate the bureaucratisation of the ECI, which is not even hinted at in the Constitution anywhere. Two visible manifestations of this are the so-called elevation of ECs to Chief Election Commissioner (CEC), and the tenures of ECs and CEC. The elevation is a clear violation of the principle of *primus inter pares*. Monopolisation of the positions of ECs and CEC by the administrative services is too obvious to need highlighting.

So, how do we find persons

who will come close to the expectation of Dr. Ambedkar and Dr. Prasad? For this, we need to go outside the existing frameworks. Marginal improvements are not going to be enough. Bold actions are called for.

For this, the following process is proposed. An existing committee of Parliament or a new committee formed for this purpose should propose the qualifications and requirements for persons to be appointed as ECs/CEC. The proposals of the committee should be put to Parliament and should be considered approved only if they are approved by two-thirds majority of the members of Parliament present and voting. Once the qualifications and requirements have been approved by Parliament, the same committee should be entrusted with the task of searching for and selecting individuals proposed to be appointed as ECs/CEC.

The committee should invite nominations and applications of individuals appropriate for or interested in being appointed as ECs/CEC.

The committee should send its recommendations to Parliament for consideration. Recommendations of the committee should be considered approved by Parliament only if approved by two-thirds majority of the members of Parliament present and voting. Once Parliament approves the recommendations, they should be sent to the President for approving the appointments. Once appointed, such persons should stay in their positions for six years or the age of 75 years, whichever is earlier. Persons above the age of 69 years should not be appointed.

Obviously, the above will be seen to be a very cumbersome process, particularly given that Parliament is more or less dysfunctional today. Nonetheless, if the democracy in its real sense is to be preserved in the country, the importance of the ECI has to be recognised and accepted.

A shot in the arm for SP-RLD alliance

It defended its bastion in Mainpuri and wrested Khatauli from the BJP

he result of the keenly contested bypolls for two Assembly seats and one Lok Sabha seat in Uttar Pradesh has come as a shot in the arm for the beleaguered Samajwadi Party-Rashtriya Lok Dal alliance in the State.

The principal Opposition defended its bastion in Mainpuri Lok Sabha and wrested Khatauli from the Bharatiya Janata Party (BJP) by cementing ties that it could not stitch during the Assembly polls earlier this year. In Rampur Sadar, Azam Khan lost his citadel but the party secured a moral point. SP president Akhilesh Yadav learnt his lessons from the reverses of Azamgarh and Rampur Lok Sabha bypolls and canvased extensively for his wife Dimple Yadav in Mainpuri, where the party's prestige was at stake as the bypoll was necessitated because of the demise of SP patriarch Mulayam Singh Yadav.

The margin of the victory swelled to almost three times that of the last polls, when the party fought in alliance with the Bahujan Samaj Party (BSP). It was fuelled by the return of Shivpal Yadav, the estranged uncle of Mr. Akhilesh, to the family fold with full force, ensuring lead in all five assembly constituencies of Mainpuri Lok Sabha. Earlier this year, the BJP won two of the segments. The biggest margin was registered in Jaswantnagar, the Assembly seat represented by Mr. Shivpal.

Mr. Shivpal was under the radar of the ruling party and when he gravitated towards the family, the frustration of the BIP was evident as Chief Minister Yogi Adityanath de-



scribed him as a pendulum.

In Khatauli, which the SP left for the RLD, the alliance went for the Muslim-Jat-Gurjar combination this time and also garnered some Dalit votes as it joined hands with Chandrashekhar Azad's Azad Samaj Party (ASP), a social coalition that the alliance missed during the Assembly polls.

By fielding a Gurjar strongman, the RLD is pursuing an aggressive brand of politics in the region to take on the local BJP heavyweights from Jat and Saini communities. The victorv has consolidated RLD president Jayant Singh's position as the foremost Jat leader despite the BJP's recent outreach towards the community that led the farmers' protest against the contentious farm laws and demand for a law against minimum support price (MSP).

Alongside the caste equation, by raising issues of hike in state approved price (SAP) of sugarcane, flaws in the Agniveer Scheme, compensation for the deceased in the Lakhimpur Kheri case and moving a private member Bill to amend the age of candidature in Parliament and State legislatures to 21 years, Mr. Singh is addressing concerns of farmers and the youth.

In Rampur Sadar, the alliance lost its bastion to the BJP but gained the moral high ground as the voting percentage remained low at 33%, raising questions on the fairness of the poll. It busted the BJP's claim that the Pasmandas in the Muslim majority seat would vote for the party.

Interestingly, with the Jat support, Muslims came out in large numbers to vote for the RLD in Khatauli, but the minority community could not find any such cover in Rampur to offset the administration, which seemed keen on a low turnout in Muslim pockets.

Being the first polls under the leadership of State president Bhupendra Chaudhary, the results have left the BJP with a lot to think about, particularly in the sugarcane belt the epicentre of communal polarisation that brought the BJP to power in 2017.

It has now lost five of six seats in the Muzaffarnagar Lok Sabha seat, represented by Union Minister Sanjeev Balyan who harvested votes for the BJP after the communal riots of 2013. Out of the four seats that are with the SP-RLD alliance, two have Gurjar MLAs and two are represented by Jats. Observers indicate that giving the reins of the State unit in the hands of a Jat leader and appointing Dharmpal Saini as the organisation general secretary has not really shown the desired result so far.

The results will also force the BSP to rethink its strategy as Muslims do not seem to be ditching the SP and a section of Dalits is seeing in Mr. Azad the fighting spirit that Mayawati once espoused. Going forward, all eyes will be on how the SP-RLD accommodates Mr. Azad and what Mr. Akhilesh offers to Mr. Shivpal.

The next test is the elections for the urban local bodies in January. While Mr. Adityanath has described it as the third engine that the party needs, the Opposition would like to build on the stimulus that the bypoll results have

With 11 million cases, infections surge globally in December

COVID-related deaths were higher even in nations with better coverage of booster shots

ver 11 million new CO-VID-19 cases were reported in December worldwide. The new infections were not confined to a region, but were spread across all continents, barring Africa.

A look at the top 15 countries which contributed the most cases in December shows that five were from Asia and Europe each, two from Oceania and South America each, and one from North America as shown in chart 1.

Chart 1 depicts the number of new cases recorded in the first 20 days of December for the top 15 countries. India's figure is also provided as a reference. Japan leads the list with 2.58 million infections followed by South Korea (1.23 million) and the United States (1.19 million). Meanwhile, India has recorded only about 3,600 cases in this period.

Chart 2 depicts the number of new deaths recorded in the first twenty days of December for the top 15 countries which had reported the most cases in this period. India's figure is also provided as a reference. The U.S tops the list with over 7,500 deaths followed by Japan (4,086 deaths) and Brazil (2,615 deaths). India has recorded 58 deaths in the period.

Notably, the number of reported deaths in China in December was nine, the lowest among the countries considered. In fact, even lower than India's, which is not part of the top 15 list and where the cases have remained very low. However, reports from China are pointing otherwise. A crematorium worker in Chongqing, a city of 30 million in the south west, told the AFP that they had run out of space to keep bodies.

In the southern megapolis of Guangzhou, an employee at one crematorium in Zengcheng district said they were cremating more

than 30 bodies a day. In the northeastern city of Shenyang, a staff member at a funeral services business said the bodies of the deceased were being left unburied for up to five days because crematoriums are "absolutely packed".

Surprisingly, deaths were also higher in countries which have made strides in vaccinations. More than 4,000 COVID-19 deaths have been recorded in Japan in December, despite 83% of the population completing the initial two doses. Moreover, 127 booster doses have been administered per 100 people in Japan – the highest among the countries listed in chart 1 and 2.

In South Korea and Taiwan too, over 500 deaths have been recorded despite at least 86% of the population receiving the first two doses and over 80 booster shots being administered per 100 people in both nations.

Chart 3 shows the % of population in the countries listed in chart 1 who took the first two doses till December 20, 2022. Chart 4 shows the number of booster shots administered per 100 people across the same countries. However, the data on vaccination status of those who died in December will help gauge the impact of vaccines better.

The charts 5 and 6 show CO-VID-related hospitalisations in the U.S. and number of patients in the ICU in France and Germany. The weekly hospitalisations in the U.S. is on a rising trend and was close to the 40,000 mark on December 18. The number of ICU patients in France and Germany were also on an increasing trend with over 1,000 such patients as of Decem-

While cases continue to be low in India, the share of people who received both the initial doses remained below 70% and only 15.7 booster shots have been administered per 100 people, which is among the lowest in the countries considered. But India also underwent three major COVID-19 waves with many infected.

Counting the cases and deaths

The graphs are sourced from ourworldindata. Cases are rising across all continents barring Africa. Deaths are increasing even in nations with better vaccination coverage




Chart 1: The chart shows the number of new cases recorded in the first 20 days of December in top 15 countries




Chart 2: The chart shows the number of new deaths in the first 20 days of December in top 15 countries with most cases




Chart 3: The chart shows the % of population who took the first two doses in the countries listed in chart 1

The INS Mormugao and its capabilities

The story so far:

n a boost to the country's maritime capabilities, INS Mormugao has officially joined the Indian Navy's fleet, marking a significant milestone for indigenous military expedition. The warship 'Yard 12705', named after the Goan port city of Mormugao, is the second of the four Visakhapatnam-class destroyers being built under the Indian Navy Project 15B, or P15B. The destroyer has multi-dimensional combat capabilities which include surfaceto-surface missiles, surface-to-air missiles and modern surveillance radar.

What is Project 15B?

Project 15 was launched in the 1990s to add guided missile destroyers to the inventory of the Indian Navy. The project was named 'Delhi class'. It was followed by Project 15A or Kolkata class which primarily focused on advanced technology and equipment in surface ships. Project 15B or the Visakhapatnam class is a follow-on class of weapon-intensive Project 15A destroyers. The project was launched in January 2011 to incorporate advanced design concepts such as state-of-the-art weapons and sensors, advanced stealth features and a high degree of automation for "improved survivability, sea keeping, stealth and manoeuvrability". The lead ship of Project 15B, INS Visakhapatnam, was the first of the class to be commissioned. Besides INS Mormugao, the other two destroyers are expected to be commissioned between 2023 and 2025.

What are the capabilities of INS Mormugao?

Regarded as "one of the most potent warships to have been constructed in the country", the destroyer is 163 metres long, 17 metres wide and displaces 7,400 tonnes when fully loaded. The ship is propelled by four gas turbines in a combined gas and gas (COGAG) configuration. The propul-

sion system allows the ship to achieve a speed of more than 30 knots (50km/h) and a maximum range of 4,000 nautical miles. It can accommodate a crew of about 300 personnel.

INS Mormugao's firepower comprises BrahMos surface-to-surface missiles (SSM) Barak-8 surface-to-air (SAM) missiles for a long range of shore and sea-based targets and a 76mm super rapid gun mount. The ship is armed with RBU-6000 anti-submarine rocket launchers and 533mm torpedo launchers. It is also equipped to carry and operate multi-role helicopters. Its enhanced stealth features ensure a reduced Radar Cross Section or radar signature.

It is automated with sophisticated digital networks such as the Gigabyte Ethernet-based Ship Data Network (GESDN), the Combat Management System (CMS), Automatic Power Management System (APMS), Integrated Platform Management System (IPMS) and Ship Data Network (SDN). While the CMS performs threat evaluation and resource allocation based on the tactical picture compiled and ammunition available onboard, APMS controls power

management. IPMS is used to control and monitor machinery and auxiliaries and the SDN is the 'information highway for data' from sensors and weapons. The ship has multiple fire zones, battle damage control systems, distributional power systems to enhance survivability in emergencies and a total atmospheric control system to protect the crew against nuclear, biological and chemical threats.

Built with over 75% indigenous content, the commissioning of INS Mormugao is a shot in the arm for India's self-reliance efforts and crucial for the 15-year Indian Naval Indigenisation Plan (INIP) 2015-2030 implemented in 2014 for indigenous development of its resources, equipment and to make the nation self-reliant in defence technology.

What is the strategic importance?

While India's interests are closely tied to the Indian Ocean, China has been rapidly expanding its naval footprint in the region. Amid growing Chinese strategic inter-

ests, India renewed its focus on bolstering its maritime capabilities in the region to counter the threat.

During the commissioning ceremony of INS Mormugao, Defence Minister Rajnath Singh reiterated the government's resolve to prepare the nation to deal with any situation arising due to the changing global scenario, "Economic, political and trade relations between countries are constantly evolving. The COVID-19 pandemic, the situation in the Middle East, Afghanistan and now Ukraine. It directly or indirectly impacts every country in one way or another. In this era of globalisation, almost all nations are dependent on each other in the field of trade. Hence, rule-based freedom of navigation, security of sea lanes etc. have become more important than ever for stability and economic progress of the world," he said.

The addition of a technologically advanced stealth warship to the naval inventory provides a strategic advantage to India and adds to the combat capabilities of the armed forces. Besides surface operations, guided missile destroyers are capable of engaging in anti-aircraft and antisubmarine warfare.

Why did the Supreme Court mandate the institution of a Committee on Content Regulation in Government Advertising? How has the Aam Aadmi Party reacted to allegations of excessive spending on advertisements?

The story so far:

elhi Lieutenant-Governor (L-G) Vinai Kumar Saxena has directed Chief Secretary Naresh Kumar to implement a 2016 order of the Committee on Content Regulation in Government Advertising (CCRGA). The order calls for recovering ₹97.14 crore plus interest from the ruling Aam Aadmi Party (AAP) for "political advertisements" published or telecast as government advertisements in 2015 and 2016. The move added to the long list of escalations between the AAP-led Delhi government and the L-G.

What is the CCRGA?

A three-member body, the CCRGA was formed by the Union Ministry of Information and Broadcasting in April, 2016, on the directions of the Supreme Court in its judgment in the Common Cause vs. Union of India case in May, 2015. The body is set up to regulate the content of Central and State government advertisements in all media platforms. The SC had also mandated States to constitute their own respective bodies. While some States have set up committees to regulate public advertising content, some have given consent to the CCRGA to monitor their advertisements.

The SC, in its order had also issued a set of guidelines for public-funded advertising by governments. Some of the guidelines mentioned include that government advertising should maintain political neutrality and avoid glorification of political personalities or projecting a positive impression of the party in power or a negative impression of parties critical of the government. They also should not be used at patronising media houses.

What is the CCRGA's 2016 order? Months after its formation, the CCRGA, following a complaint from Congress leader Ajay Maken, issued notices to the Delhi government on allegations of violation of the SC-mandated guidelines in

In its response, the Delhi government

publishing advertisements.

informed the CCRGA that it was going to form a committee of its own as per the 2015 order of the SC, which mandated that States have to set up their own respective bodies to regulate government advertisements' content. Mr. Maken meanwhile had also approached the Delhi High Court in the matter, which ruled in August, 2016, that Union Territories are not authorised to constitute their own committees and will therefore, come under the jurisdiction of the CCRGA. The

CCRGA, after its investigation, passed an

order on September 16, 2016, ruling that a

number of Delhi government advertisements had violated the guidelines on various fronts such as publishing false/misleading ads, mentioning the party in power by name, self-glorification and targeting political opponents. The committee also directed the Delhi government's Directorate of Information and Publicity (DIP), which issues government campaigns, to identify specific advertisements, quantify the money spent on them, and recover it from the AAP.

After quantifying an amount of ₹97,14,69,137 spent on these advertisements, the DIP on March 30, 2017, directed AAP convener Arvind Kejriwal to pay ₹42,26,81,265 to the State exchequer immediately, and to release the remaining amount directly to the agencies/publications which ran the advertisements within 30 days.

What has been the AAP's response? The AAP has been at the receiving end of political criticism, with rival parties accusing it of spending huge sums of money on government advertising campaigns and publicity. However, the party, since forming the government in 2015, has been defending its spending on advertisements stating that it is for public knowledge of different government schemes and various awareness

campaigns.



Tis' the season to be jolly: books which bring tidings of comfort and joy

As Christmas is celebrated with its own regional flair across the country, there are numerous novels, stories and murder mysteries to dip into; the pages are bound to bring you plenty of holiday cheer, festival warmth and some thrills

he season of red and green tinsels, plum cakes and snowmen (in our case figures made out of cotton balls and ample amount of glitter) is here. Christmas, while being primarily a religious festival, is celebrated culturally by people from all walks of life across the world. The happiness of the 'good news' announced to the shepherds and the Magi from the East all those years ago has transmuted now to sentiments of forgiveness and good-cheer, an aura we associate particularly with Christmas.

Cakes, carols and Christmas movies are some of the trademark ways through which Christmas is celebrated. A humble category we often fail to include are Christmas stories and novels. From classics to mystery to tear-jerkers, books are also a way through which one can get right into the Christmas spirit.

A trip down memory lane

"Oh! but he was a tight-fisted hand at the grindstone. Scrooge! a squeezing, wrenching, grasping, scraping, clutching, Christmas books is complete or even begins without mentioning A Christmas Carol by Charles Dickens. The novella was first published in London by Chapman & Hall in 1843, with illustrations by John Leech. The story revolves around Ebenezer Scrooge, a miserly old man who is visited by three ghosts, the Ghost of Christmas Past, the Ghost of Christmas Present and the Ghost of Christmas Yet to Come. The ghosts take old Scrooge through his life, trying to make him understand what Christmas is about and how it will all be too late if he doesn't open his hand and more importantly his heart. Tiny Tim, a crippled toddler, the son of Scrooge's clerk, is an especially moving figure in the novel. It is his

resilience and optimism in the face of his disability and poverty which breaks Scrooge. The story emphasises how Christmas is much beyond a decorated tree, roast-chicken and wine; it is a time of family, friendship and renewal.

"Why, for fifty-three years I've put up with it now, I MUST stop Christmas from coming... But HOW?", the Grinch wonders in How the Grinch Stole Christmas! by Theodor "Dr. Seuss" Geisel written in rhymed verse with illustrations. Set in the town of Who-ville, the Grinch hates Christmas. As he makes plans to sabotage the festival, he realises that whatever he may say or do won't stop Christmas from coming. This small story is yet another classic which makes us look beyond the increasing commercialisation of Christmas to what its true spirit entails.

A dose of mystery and sentiment

Peace and goodwill with a whole lot of blood. These seemed to be the overarching themes in mind when Agatha Christie wrote Hercule Poirot's Christmas in 1938. If stories of Christmas cheer and joy turn too saccharine, a gory Christmas murder would be the right avenue to turn to. In the novel, we are introduced to Simeon Lee, an invalid old man who invites his entire family to spend Christmas together, under one roof. The drama is centred around him and his sons - Alfred Lee, the ever-devoted son. and his wife Lydia, George Lee, the miserly parliamentarian, and his young wife, mama's boy David Lee, and his sensible wife Hilda and the black sheep cum prodigal son Harry Lee. Simeon Lee wishes to mend bridges and let bygones be bygones in the spirit of 'peace and goodwill'. Or so he says. But all is not what it seems when the patriarch is found brutally murdered leaving everyone in shock. Everyone but of course, the bearer of grand moustaches, Hercule Poirot. If a murder mystery seems rather

National Mathematics Day is celebrated on December 22 every year in

unconventional, a heart-wrenching tale of a father who does not have much time to live, looking back at his life might seal the deal. In *The Deal of a Lifetime*, Fredrik Backman tells the story of a father and his son and the 'women in the grey sweater and folder' who comes every other night to the cancer ward. The father ponders about his relationship with his son one lonely Christmas. He also looks upon his legacy, having achieved the lengths and depths which one could only dream of, especially when one is from an obscure small town like Helsingborg situated in the southernmost part of Sweden. All this until he is offered the deal of a lifetime. 'A life for a life'.

The Indian connect

"O the white dust on the highway! O the stenches in the byway!

O the clammy fog that hovers over

And at Home they're making merry 'neath the white and scarlet berry What part have India's exiles in their

– writes Rudyard Kipling in his poem Christmas in India. Kipling laments about landscape among strangers. One wonders what Mr. Kipling would say if he saw Christmas in India now. But which Christmas shall we show him? In a nation as diverse as India, is there ever just one Christmas?

In Indian Christmas, an anthology of essays, hymns and memories edited and contributed to by Jerry Pinto and Madhulika Liddle, this very question is addressed in detail through authors who remember their own Christmases and how the region they occupied informed their celebrations, right from the ingredients used in the cake to the church they attended. Pinto and Liddle start off the collection by fondly talking about their childhood memories of Christmas in Bombay and Uttar Pradesh respectively. Pinto recollects the rather emaciated Santa Claus and Jim Reeves records and ponders on the birth of the baby, the reason for the season, a refugee in a foreign land who was turned away from everywhere, while Liddle elaborates on Christmas at her ancestral home (dua ka ghar, the house of prayer).

In the subsequent plethora of essays, different authors describe their experience of the festivities in their respective hometowns - Kerala, Goa, Calcutta, Chennai, Shillong, Chandigarh and so on. The geographical location and social context added its own flair to the Christmases celebrated across India.

India's pluralist history has a direct bearing on these multi-cultural experiences within Christmas. Manimugdha. S. Sharma in his essay titled 'How India's Pluralistic Past Shows the Way Forward' explains how India has always embraced different cultures and ways of life. While in 1581, Jesuit priests were being hanged by Queen Elizabeth Tudor in her mission to get rid of the Catholics, in the court of Mughal emperor Akbar, Jesuit priests were welcomed and their faith celebrated. Over the years Christianity has flourished alongside Islam and Hinduism and other religions, borrowing and giving from one and another, building up for itself a syncretic character. He ends the essay on a word of caution wherein he refers to the attack on Christmas by vigilante forces and hate groups who denounce the 'foreign festival' in the name of God and country. But as Liddle writes, "Indians adopted Christianity, but made it their own".

Similarly, Christmas, often celebrated on a warm summer morning in the south or in sweater weather up-north (dreams of a White Christmas unfortunately often stay as dreams), is 'Indian' precisely because of its cultural variations and will hopefully remain so for years to come.



Variant linked to China spike first found in July

India has been reporting a "steady decline" in cases, with average numbers around 158 every day in the week ending December 19. Globally however, there has been a rise in daily average cases in the last six weeks, with about 6 lakh instances reported weekly as of December 19, the Health Ministry said in a statement. The dominant variant in India currently is Omicron AB5, (which is linked to BF.7) although this is based on extremely limited numbers.

"Whether BF.7 behaves differently in a population that has been minimally exposed to the coronavirus as opposed to Indians who have hybrid immunity (multiple doses of the vaccine along with exposure to several variants of the virus) is being investigated by the Indian Council of Medical Research," one of the officials told *The Hindu*.

An expert told The Hindu that India's real worry was not BF.7 but XBB, a recombinant variant that is a combination of two lineages (BJ.1 and BA.2.75). It is "highly infectious" and had the potential to evade antibodies from existing vaccines. (With inputs from Satyasundar Barik)

Follow COVID protocols or suspend yatra'

"Follow the COVID guidelines strictly during Bharat Jodo Yatra. Use of masks-sanitiser should be implemented. Only vaccinated people should participate," Mr. Mandaviya said in a letter to Mr. Gandhi and Rajasthan Chief Minister Ashok Gehlot on Tuesday. The Health Minister said that BJP MPs from Rajasthan P.P. Chaudhary and Nihal Chand had written to him, expressing concerns over the guidelines not being followed.

Reacting to the letter, Congress's communications chief Jairam Ramesh said in a statement, "Parliament is meeting normally. Masks are no longer compulsory anywhere, including on flights. BJP has taken out yatras in Rajasthan and Karnataka. There has been no advisory from the Centre to States of late except the one issued yesterday on genome sequencing." "Public health is far too serious a issue on which to play party politics. If there is a protocol for gatherings, Bharat Jodo Yatra will abide by it undoubtedly," he added.

Mr. Gehlot said the BJP was upset with the popularity of the long march and wanted to disturb it. "Two days ago, the Prime Minister addressed a rally in Tripura, where no COVID protocol was followed. If the Health Minister is really concerned [about COVID infection] and his intent is not political, then he should have written the first letter to the Prime Minister," Mr. Gehlot said.

'Unemployment and inflation hurting India'

Attacking Prime Minister Narendra Modi over price rise, Mr. Gandhi said that while Mr. Modi used to talk about inflation earlier, the prices of cooking gas cylinder and petrol had increased several fold during the present regime.

"A cooking gas cylinder cost ₹400 during the UPA rule, but now it is priced at ₹1,200. Similarly, petrol price has crossed ₹100 per litre mark now, while it cost only ₹60 during the UPA regime," he

Mr. Gandhi, without naming anyone, said there was an attempt to hand over the country's entire wealth to a few big corporate houses. He added that demonetisation and the Goods and Services Tax were not "policies", but "weapons" to kill small and medium traders.

He also made a suggestion to Congress party president Mallikarjun Kharge to ensure that wherever the Congress is in power, the party's Ministers and MLAs must hit the road once a month to connect with the masses.

Congress's communications chief Jairam Ramesh, at a press conference, said the vatra was a "historic step" for the Congress and also a "moment of change" for Indian politics.

Forest buffer zone won't affect people: Pinarayi

He said the government published the survey report so the affected families could flag the anomalies in the survey and help the government incorporate the overlooked details in its final report to the court to bolster the State's case for a total exemption of human habitats from the intended ESZ. Mr. Vijayan deflected the blame on the Congress for precipitating the situation. He said Congress leader and former Union Minister for Forests and Environment Jairam Ramesh was bullish about establishing a 10-km wide ESZ around forests. Several Congress persons, including Opposition Leader V.D. Satheeshan, backed the "thoughtless" move.

He said the previous government proposed extending the buffer zone to 12 km. In 2019, the LDF government whittled it down to "zero to one km", with a total exemption for human habitats, given mounting public anxiety.

Mr. Vijayan said Kerala and other like-minded States convinced the Central government to withdraw the unworkable stipulation that the National Board For Wildlife permission was mandatory for any construction within a 10-km radius of the boundary of protected forests.

Delhi excise case: court takes cognisance of chargesheet

ED alleges that all the five named accused were found to have indulged in activities related to the generation of the proceeds of crime or associated offences, either directly or indirectly

special court has taken cognisance of a chargesheet filed by the Enforcement Directorate (ED) against Indospirit Group managing director Sameer Mahendru and four others in connection with the Delhi excise policy case. The agency has so far detected ₹2,873 crore as alleged proceeds of crime.

Taking cognisance of the chargesheet, Special Judge M.K. Nagpal on Tuesday said that based on the contents of the complaint, statements of witnesses and other documentary evidence provided by the ED, it appeared that all the five named accused were found to have either directly or indirectly indulged in the activities related to the generation of the proceeds of crime or associated offences.

Among those named as accused in the chargesheet are Mr. Mahendru, Khao Gali Restaurants Private Ltd,, Bubbly Beverages Private Ltd., Indo Spirits and Indospirit Distribution

Ltd. The ED's money laundering investigation is based on a case registered by the Central Bureau of Investigation on August 17 against Delhi Deputy Chief Minister Manish Sisodia and others. It has carried out 171 searches in several States and arrested Mr. Mahendru, P. Sarath Chandra Reddy, Benoy Babu, Vijay Nair and Abhishek Boinpally in connection with the case.

Based on the findings, the agency has alleged that the Expect Committee's recommendations for the excise policy 2021-22 were modified as part of a conspiracy to "generate illegal

'Meticulously planned' "The policy was formulated with deliberate loopholes, inbuilt mechanism to facilitate illegal activities and is marred with inconsistencies. It promoted cartel formations through back door, awarded exorbitant wholesale (12%) and huge retail profit margin of 185% and incentivised other illegal activities. The 12% profit margin to wholesalers was devised to extract a portion of it (about 6%) as a kickback to AAP leaders,"

ED, the then AAP media promotion in-charge Vijay Nair, on behalf of the party leaders, received kickbacks to the tune of ₹100 crore from the "South Group" whose prominent persons were Magunta Srinivasulu Reddy, Raghav Magunta, Sarath Reddy and K. Kavitha. In order to recover the

kickbacks were paid in ad-

vance. According to the

money paid by the group, its partners were allegedly given 65% stakes in wholesale licensee Indo Spirits in collusion with Mr. Mahendru, as directed by Mr. Nair, the agency said in the chargesheet. It alleged that the group directly and indirectly controlled nine retail zones.

Centre withholding Bengal's MGNREGS funds: Trinamool

Withholding funds due to West Bengal under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) is "political discrimination" by the Union government, the Trinamool Congress said in the Rajya Sabha, as the two sides sparred on the issue in the Upper House on Wednesday. Invoking Section 27 of

the Mahatma Gandhi National Rural Employment Guarantee Act (MGNRE-GA), the Centre has blocked payment of over ₹7,500 crore of funds to West Bengal for "non-compliance of directives of the Central government". Of this amount, the wage liability is ₹2,744 crore. With panchayat polls scheduled just months away in March 2023, the Trinamool is arguing that the Union government had wilfully denied wages to the poor, who had not been paid over a year for the work they did under the scheme.

During the Question Hour in the House, Trinamool MP Jawahar Sircar asked the Rural Development Ministry for details on the States that had not Ministry says that funds were frozen after the State failed to send a response to the questions

received any funds in the ongoing financial year under the MGNREGS.

In response, the Minister of State for Rural Development, Sadhvi Niranjan Jyoti, said only West Bengal fell under this category. Mr. Sircar alleged "gross injustice" against the State, in spite of the fact that Chief Minister Mamata Banerjee had ordered verification of every job card.

'No discrimination'

Ms. Jyoti said the Centre did not "discriminate" against any State. "But there are a few guidelines under the MGNREGA that all States have to follow. She added that the funds were frozen after the State government failed to send in a detailed response to the questions raised by a Central team that investigated the implementation of the scheme in 2019.

"This is political discrimination before our panchayat elections," Mr. Sircar claimed.

Chinmayanand gets interim anticipatory bail in rape case

New land rules bring J&K on a par with rest of India; old law was regressive: L-G

Toughening the stand on newly introduced land rules that has ended lease holders' rights for extension in the Union Territory (UT), Jammu and Kashmir Lieutenant-Governor Manoj Sinha on Wednesday said the land laws were "regressive" and "property worth ₹100 crore property was enjoyed at a paltry ₹5".

"No poor will be impacted by the amendments to the land laws. Rule of law outside has to be implemented here too. J&K's land laws were regressive and amendments were made. There were properties worth ₹100 crore being enjoyed for ₹5 as payment. Only such people are worried by the amendments," Mr. Sinha said in Jammu.

The Land Grants Rules, 2022 has paved the way to auction all commercial buildings on lease and land on lease in J&K. The Lieutenant-Governor said the fresh rules "have brought

The Supreme Court stood up for the little man against the power of the State by putting an end to "frivolous" rounds of litigation waged by the School Education Department of the Tamil Nadu government against a sweepercum-sanitary worker who wanted his pension after putting in 20 years of work for a starting wage of ₹150 a month.

A Bench led by Justice Dinesh Maheshwari backed the cause of K. Lakshmanan's right to pension and directed the department to cough up exemplary costs of ₹1 lakh for "dragging on" the litigation for years, even at one point filing the rare review petition in the Madras High Court, which ordered the State to pay him the pension. The costs have to be deposited in the welfare fund of the Supreme Court Welfare

"recover the amount of costs from the persons/officers responsible for protracting this litigation and sanctioning such frivolous petitions without sufficient cause and without any justification".

Protector of rights

There is a calculated bid to delegitimise judiciary, says Sonia

There is a calculated attempt to delegitimise the judiciary, Congress Parliamentary Party (CPP) chairperson Sonia Gandhi said on Wednesday. She also attacked the Narendra Modi government for refusing to discuss the India-China border issue in Parliament.

She made these remarks at the general body meeting of the CPP at Parliament's Central Hall.

In a scathing attack, Ms. Gandhi said the Modi government's refusal to a parliamentary debate showed "disrespect to democracy and poorly reflected the government's intentions".

"Ministers and even a high constitutional authority have been enlisted to make speeches attacking the judiciary on various grounds. It is quite clear that this is not an effort to provide reasonable suggestions for improvement. Rather, it is an effort to reduce the standing of the judiciary in the eyes of the public," she alleged.

But the focus of Ms. Gandhi's speech was the government's handling of the border issue with China. "The continuing incursions by China on our border are a matter of serious concern. The whole nation stands with our vigilant soldiers who repelled these attacks under difficult conditions. The government, however, stubbornly refus-



es to allow a discussion on the issue in Parliament. As a result, Parliament, political parties and the people remain ignorant of the true situation on the ground," she said.

Economic response

"What is the government's policy to deter China from future incursions? Given that we continue to have a severe trade deficit with China, importing far more than we export, why is there no economic response to China's military hostility? What is the government's diplomatic outreach to the global community," Ms. Gandhi asked.

On Wednesday, the Congress-led Opposition MPs stepped up their demand for a discussion on China by protesting in front of the Parliament House and later staged a walkout in the Lok Sabha.

Talking about the recent elections, Ms. Gandhi said the Congress had formed its government in Himachal Pradesh but termed the results in Gujarat and Delhi "unfortunate".

'Targeted relief given during the pandemic staved off recession'

Revenue buoyancy will be enough to take care of additional expenses of ₹3.25 lakh crore this financial year, says Nirmala Sitharaman

NEW DELHI

he country did not slip into an economic recession because of the targeted approach taken by Prime Minister Narendra Modi to give relief to people during the COVID-19 pandemic, Finance Minister Nirmala Sitharaman said on Wednesday.

She was replying to a debate on two Appropriation Bills seeking House approval for additional funds to be used during this financial year. Both the Bills were returned by the Rajya Sabha after her reply.

Responding to former Finance Minister P. Chidambaram, who spearheaded the Opposition by initiating the debate on Monday, Ms. Sitharaman said the countries which went by the advice of "borrow and spend and even print money to reboot the economy" had to face recession. "Thankfully, the targeted way in which the Prime Minister decided to give relief during COVID-19 and address the concerns – that were given as inputs from various stakeholders – has kept us on the safe course of helping revival, and not getting into recession," she said.

She said both the IMF and the World Bank had said on several occasions that India was the brightest spot in the global economy and was an island of hope for global growth.

Food security

On questions about an additional expenditure of ₹3.25 lakh crore in 2022-23, she said the Centre had come up with the Supplementary Demand for Grants essentially to ensure food security and subsidy for fertilizers, which is critical for farmers.

On the revenues for this additional expenditure, she said, "In September itself, the Government of India had made it very clear that we are not changing our borrowing schedule." The Minister said the Centre would ensure that the revenue generated would be sufficient to take care of the addition, emphasising that there was enough buoyancy that gave her confidence.

On cutting corporate tax, Ms. Sitharaman recalled that in 1991, then Finance Minister Manmohan Singh cut it to 40% from

"Then in 1997, the then Finance Minister P. Chidambaram brought the corporate tax down to 35% from 40%, after abolishing the surcharge also. Then, from 2000, surcharges were back, raising the total corporate tax again to about 36-38% which continued for the next five years after that. But, then, it was Mr. Chidambaram again, who reduced the corporate tax to 30% in 2005, although along with the surcharge, the actual rate was about 33%. Were they also a bonanza to corporates," she asked

Maritime Anti-Piracy Bill passed in Rajya Sabha

The Hindu Bureau NEW DELHI

The Rajya Sabha on Wednesday passed the Maritime Anti-Piracy Bill on Wednesday, two days after the Lok Sabha cleared it.

External Affairs Minister S. Jaishankar said the Bill would fulfil all the expectations of the United Nations Convention on the Law of the Sea (UNCLOS), which India is a signatory to, for cooperation and repression of piracy in high seas.

Addressing the concerns raised by the Standing Committee on Transport and Shipping, the Centre has dropped the provision for trial in absentia through amendments brought in the Lok Sabha. The Bill also addresses the issue of death penalty "as an exceptional case". The quantum of punishments envisaged are in line with the gravity of offences.

Mr. Jaishankar, replying to a brief debate, said that between 2008 and 2011, there were 27 maritime incidents where 288 Indian nationals were involved. "Between 2014 and 2022, there were 19 piracy cases in which 155 Indian crew members were involved and the numbers show why the country needs this Bill so badly," he added.

"It will strengthen our maritime security, including the safety of our maritime trade routes and the well-being of Indian seafarers in international waters," Mr. Jaishankar said.



Bihar CM lashes out at Centre for 'raising' COVID-19 scare

Bihar Chief Minister Nitish Kumar took a dig at BJP-led Central government on Wednesday for raising an alarm over a COVID-19 spike at a time when Congress leader Rahul Gandhi's Bharat Jodo Yatra was gaining momentum. "First of all it should be known why they [the ruling BJP at the Centre] had become laid-back over COVID-19 and why they have become vigilant when the Congress people are taking out Bharat Jodo Yatra which is gaining momentum now," Mr. Kumar asked. "Why do these people [the BJP] have an objection to the yatra and why do they themselves keep taking out processions?" he asked. He also lashed out at a NHRC team visiting Bihar in the wake of the Saran hooch tragedy, asking whether such teams had visited other States where similar tragedies had taken place.

RJD seeks apology from Goyal for comments on Bihar

The RJD, on Wednesday sought an apology from Union Minister Piyush Goyal for his alleged "demeaning" remarks against Bihar. In a letter to Rajya Sabha Chairman Jagdeep Dhankhar, party MP Manoj K. Jha said that Mr. Goyal's comments are "representative of the contemptuous and condescending attitude of the Government of India towards Bihar". On Tuesday, during Mr. Jha intervention in a debate on the Appropriation Bill, Mr. Goyal interjected and said "If they have their way, they will turn the country into Bihar." Objecting to the comments, Mr. Jha in a letter to Mr. Dhankhar said, that such a "demeaning" statement was not expected from a person of Mr. Goyal's rank. It is deeply problematic, he said, that the government is singling out one State and terming it a "failure".

No plan to revise age of consent, Centre informs Rajya Sabha

The Union government does not yet have a plan to revise the age of consent under the Protection of Children from Sexual Offences Act, 2012 despite appeals from the judiciary to lower it from the current 18 to 16.

In response to a question from CPI member Binoy Vishwam in the Rajya Sabha on whether the Centre was considering any proposal to lower the age of consent in order to prevent the criminalisation of consensual relationships between adolescents, Union Minister for Women and Child Development Smriti Irani replied, "does not arise."

"The Act clearly defines a child as any person below the age of 18 years. The Act provides punishment as per the gravity of offence. The Act was further amended in 2019 to introduce more stringent punishment including death penalty for committing sexual crimes on children, with a view to deter the perpetrators & prevent such crimes against children," she said.

Ms. Irani also said that the Majority Act, 1875 provided 18 years as the age for attainment of majority. She said that where an offence listed under the POC-SO Act was committed by a child, Section 34 provided procedures for determining the age of the juvenile accused.

He said that drugs network chart had been sent to the States after manning the route of drugs and its network in 472 districts.

The government was also setting up six regional labs so that there was no delay in the testing of samples and criminals cannot escape.

Human Rights panel seeks report on evictions in Assam

The Assam Human Rights Commission (AHRC) on Wednesday asked the district administration of Nagaon in central Assam to submit a report on the eviction of about 300 families who had allegedly occupied government land.

The deadline for the submission has been set as January 18, 2023.

The eviction drive around the birthplace of 15-16th century Vaishnav saintreformer Srimanta Sankaradeva in Batadrava began on December 19. The encroachers had built permanent houses and fish breeding farms on the occupied land, officials said.

Chief Minister Himanta Biswa Sarma justified the eviction drive and said a similar drive would soon take place in Goalpara district. "There is no point talking about such eviction exercises, which will continue until all the forest and government lands across the State are cleared," he said.

907 naxal sympathisers surrender in Odisha

As many as 907 sympathisers, including 467 active militias of the CPI(Maoist), have surrendered before the Odisha police and the Border Security Force in Swabhiman Anchal of Malkangiri district, once a hotbed of left wing extremists in the State. These individuals belonged to villages which used to be the stronghold of the CPI(Maoist) where security forces were finding it difficult to venture into. "All these villages are located on the Odisha-Andhra Pradesh boundary. These Maoist supporters used to assist extremists in violent activities and were involved in the killing of security forces and civilians," Nitesh Wadhwani, Superintendent of Police, Malkangiri, said.

NCW asks SpiceJet to take down tweet on its cabin crew

The National Commission for Women (NCW) has asked SpiceJet chairman and managing director Ajay Singh to take down a post on social media that refers to the airline's cabin crew as "red-hot girls". Meanwhile, the airline has asserted that the reference was part of its tagline used often for "product promotions". On December 19, SpiceJet, on its Twitter timeline, posted a picture of its women cabin crew posing with Bollywood actor Dharmendra along with the caption "Garam Dharam with our red-hot girls". A passenger complained about the "sexist remark" that he said was antithetical to "Indian culture" and tagged the NCW.

U.P. targets to make Ganga clean before 'Kumbh 2025'

Before the commencement of 'Prayagraj Kumbh 2025', the Uttar Pradesh government has vowed to make the Ganga clean through the 'Namami Gange' mission. Chief Minister Yogi Adityanath on Wednesday gave guidelines for it while reviewing the implementation of the 'Namami Gange' project. Mr. Adityanath directed officials to expedite the process of installation of sewage treatment plants (STPs) to save the rivers from sewage, dirt and toxic water, and called for more efforts for urban solid waste management in order to ensure uninterrupted and clean flow of all the rivers, including the Ganga.

Bombay HC extends stay on bail granted to NCP leader

The Bombay High Court on Wednesday granted extension on the stay of former Home Minister of Maharashtra Anil Deshmukh's bail to the Central Bureau of Investigation (CBI) till December 27. A Single Bench of Justice M.S. Karnik granted time to the CBI to challenge Mr. Deshmukh's bail order in the Supreme Court. Though the Nationalist Congress Party (NCP) leader was granted bail by the High Court on December 12, the same Bench had stayed it for 10 days. Mr. Deshmukh, 73, is currently lodged at the Arthur Road Jail and was arrested by the CBI in 2021 in a corruption case involving ₹100 crore. He was granted bail by the Bombay High Court on medical grounds.

'Only 30% reserved vacancies at IITs, Central universities filled in a year'

Of the 1,439 vacancies identified in the year to September 2022, only 449 were filled from the categories, show Education Ministry data; 12 Central universities conducted almost no recruitment during the mission-mode hiring drive

espite a year-long mission-mode recruitment drive to hire faculty for reserved category positions at the elite Indian Institutes of Technology and Central universities, just over 30% of identified vacancies were filled, the Education Ministry told Parliament this week.

In the year to September 5, 2022, 23 IITs and 45 Central universities across the country were directed to conduct the drive to fill vacancies in teaching positions reserved for the Scheduled Castes, Scheduled Tribes and Other Backward Classes.

During this period, 1,439 vacancies were identified, against which just 449 recruitments were made.

Of the 45 Central universities, 33 had identified a

total of 1,097 vacancies in these categories, of which just 212 were filled.

Even among these 33 universities, the data revealed that 18 of them had recruited no SC, ST or OBC teaching faculty at all, despite having identified vacancies.

Top universities too Among these 18 Central universities, Jawaharlal Nehru University had iden-

tified 75 vacancies; Banaras Hindu University 114; and Babasaheb Bhimrao Ambedkar University seven. However, none of these vacancies were filled.

Twelve of the Central universities conducted almost no recruitment during this drive, saying they had no backlog and could not identify any vacancies in these categories.

As of September this year, the data presented in

Parliament showed that Central universities had a combined backlog of over 920 positions in the SC/ST/ OBC categories for teaching faculty.

Low recruitment

Of the 23 IITs, only 10 were able to identify 342 vacancies in these categories for positions of Professor, Associate Professor and Assistant Professor.

A total of 237 positions in these categories were filled at 19 IITs. An analysis of the raw data by the Ambedkar Periyar Phule Study Circle (APPSC) of the IIT, Bombay showed that 13 IITs were unable to identify vacancies to be filled in this recruitment drive because they follow a "flexible cadre structure for faculty positions".

However, despite this, except for three (the IITs in Hyderabad, Bhilai and Bhubaneswar), the others did recruit a small number

of SC/ST/OBC faculty in this time. The analysis further showed that 358 vacancies remained at 14

Of the recruitments done in this time period, the APPSC found that no ST candidates were recruited at the IITs in Kharagpur, Roorkee, Tirupati, Goa and Dharwad and the IIT ISM Dhanbad.

Further, no SC candidate was recruited in the IIT Roorkee.

It was found that most IITs did not recruit SC/ST/ OBC candidates at the Professor and Associate Professor levels.

ED withholds production warrant for Mondal

The Enforcement Directorate (ED) on Wednesday assured the Delhi High Court that it will withhold till January 9 the execution of a warrant to produce Trinamool Congress leader Anubrata Mondal before a local court here in connection with a money laundering case. Mr. Mondal is currently lodged in an Asansol jail in a cattle smuggling case in West Bengal.

A Delhi court on Monday issued a production warrant against Mr. Mondal after the ED approached the court seeking that the Birbhum district president of the Trinamool Congress be summoned to Delhi for questioning.

He was arrested by the Central Bureau of Investigation (CBI) on August 11 and has remained behind bars since. The ED is looking into the money laundering aspect of the alleged scam.

11 fishermen from T.N. arrested by Sri Lankan Navy

PM2 elephant acclimatising to habitat in MTR, positive behaviouralchanges noticed



Living as one pleases, and yielding to temptations, is not penance. Think of a shining nail which sits tightly in its slot in the yoke of a bullock cart. Our thoughts must have the same focus as the unmoving nail in the yoke, says poet Mundrurai Araiyanar.

Poet Kari Asan says that not harming others, forgetting one's own problems, keeping one's temper in check, giving up desires - if a man has these qualities, then his penance will be successful. Kanimedhaiyar authored a work called Eladi, in which he says being unattached to family life is penance. Bearing one's misfortune uncomplainingly, and abstaining from harming others - these two qualities are the very essence of penance, says Thiruvalluvar.

U.S. to send precision bombs and Patriot missiles to Ukraine

Zelensky is set to visit White House; the Patriot will be the most advanced surface-to-air missile system the West has provided to Ukraine

he Biden administration announced Wednesday that it will provide \$1.85 billion in military aid to Ukraine, rolling out funding for a Patriot missile battery as Ukrainian President Volodymyr Zelensky is arriving in Washington for his first known trip out of his country since Russia invaded in February.

The White House announcement came just hours before Mr. Zelensky was expected to arrive. The package includes \$1 billion in weapons and equipment from Pentagon stocks, including the Patriot battery for the first time, and \$850 million in funding through the Ukraine Security Assistance Initiative (USAI).

Part of the USAI will be

used to fund a satellite communications system, which likely will include the crucial SpaceX Starlink satellite network system owned by Elon Musk.

The Patriot will be the most advanced surface-toair missile system the West has provided to Ukraine to help repel Russian aerial

The Pentagon will send an undisclosed number of Joint Direct Attack Munitions kits, or JDAMs, to Ukraine.

Meanwhile, the Kremlin warned that increasing the supply of U.S. arms to Ukraine would aggravate the devastating 10-month war ignited by Russia's invasion and "does not bode well" for the neighbouring country, where President Vladimir Putin vowed Russia would achieve its goals.

China limits its definition of COVID-19 death count

China only counts deaths from pneumonia or respiratory failure in its official COVID-19 death toll, a Chinese health official said, in a narrow definition that limits the number of deaths reported.

Deaths that occur in patients with pre-existing illnesses are not counted as COVID-19 deaths, said Wang Guiqiang, the head of infectious disease at Peking University's No. 1 Hospital.

China has always been conservative in how it counts illnesses, whether from the flu or COVID-19. In most countries, including the U.S., guidelines stipulate that any death where COVID-19 is a factor or contributor is counted as a COVID-19-related death.

On Wednesday, China reported no new COVID-19 deaths and in fact subtracted one death from the overall toll, lowering it to 5,241, according to a daily

'Hugs, screams and cries': Afghan women anguished at university ban

Women university students across Afghanistan were in disbelief on Wednesday, barred by the Taliban from studying and condemned to a life of feeling "like caged birds".

In Kabul, home to the country's largest universities, students gathered outside campuses dressed in the black cloaks and tight headscarves imposed by the Taliban since they took control last year.

"We all felt like caged birds, we hugged each other, screamed, and cried 'why is this happening to us'?" Ms. Amini, a 23-yearold nursing student in Kunduz, told AFP.

Faculties across the country were already closed for the winter

break, but students had been able to access campuses for exams or to study in libraries.

In Kandahar, the cradle and spiritual heart of the Taliban movement, male students were able to sit for exams in classrooms segregated with screens, which until the

day before made it possible for women to study.

Now, the university gates shut them out.

"It really expresses (the Taliban's) illiteracy and poor knowledge of Islam and human rights," said a young male law student in Kabul

In the eastern city of Ja-

lalabad, some male students walked out of their exams in protest against the decision.

"We have no power to do anything and there is no one to listen to us," said one 29-year-old, who is doing a masters in Pashto literature in Kabul.

Deep in anguish, she still clung to the hope that the Taliban would row back on the announcement after the winter break.

"We will wait for the next three months to see if they change their order. They might change their policies and restart the universities."

If they do not, she called on men to stop attending classes in protest. "They too must stay at home until the girls are allowed to go back," she pleaded.

Sri Lanka is awaiting assurances from India, China, says Central Bank Governor

Sri Lanka is waiting for financing assurances from its bilateral creditors, including India and China, to tap support from the International Monetary Fund (IMF), according to Central Bank Governor P. Nandalal Weerasinghe.

In September, the IMF reached a staff level agreement with Sri Lanka for a \$2.9 billion package to help the island nation facing its worst economic crisis in decades. The development came months after Sri Lanka floated the rupee, opted for a preemptive default on its external debt, and increased interest rates sharply to tighten monetary policy.

However, Sri Lanka must now obtain adequate financing assurances from its creditors, for the IMF Board to approve the promised Extended Fund Facility (EFF). Colombo is desperate for the \$2.9 billion not because it is a big amount - it can barely meet two months' worth of imports - but mainly to use the IMF package to qualify for more credit internationally.

Over the past few months, Sri Lanka has been in talks with China, Japan, and India – its three major bilateral creditors to restructure the billions of dollars owed to them. "We have shared all the information possible with our bilateral creditors, on

an open, comparable, and transparent basis. Now they will have to look at it, make their decisions internally and come back to us...we hope they will do that soon," he told The Hindu in an interview at his office on Tuesday. From the time the Sri Lankan government entered the provisional agreement with the IMF, India has underscored the need for "creditor equitability and transparency", implying Colombo must not give any creditor preferential treatment while restructuring their loans.

Delayed talks

Sri Lanka aimed to secure IMF relief before the end of this year, but with bilateral negotiations dragging, it failed to. Talks with China got a "little delayed", Governor Weerasinghe observed, citing "internal issues" such as the Chinese Communist Party (CCP)'s national congress held in October, and "COVID-19 restrictions" in China.

But the delay in discussions with China "is not the only reason" for Sri Lanka's inability to secure the IMF package this year, in his view. Japan, and the Paris Club of which it is a member, "know this business" [of debt restructure] as they have "been doing it for many years", he said. "Because of that, they are more advanced in their engagement. They have done the analysis and shared it with non-Paris Club members like India and China," Mr. Weerasinghe said, adding: "Now, it is up to them." After the creditors provide financing assurances, it would likely take the IMF Board four to six weeks to approve the package, he said.

In addition to bilateral loans, the island nation has over the years borrowed heavily from private creditors, the country's largest external credit source, holding nearly \$13 billion of its outstanding debt, apart from multilateral

The focus, however, is on bilateral creditors whose role is key for Sri Lanka to obtain crucial IMF support. Multilateral loans, taken on low-interest and over a long term, will not be restructured, and the actual negotiation with commercial creditors will commence only after the IMF programme kicks in, according to the Governor.

With Colombo's decision to default on its \$51-

billion foreign debt - the Governor maintained it was a "debt standstill" as against a hard default – its subsequent move limiting imports to essentials, the nearly \$4 billion Indian assistance and some repurposed funds, Sri Lanka waded through the last few months. "We can manage without bridge financing now," Mr. Weerasinghe said. "With our export proceeds, worker remittances, and some support from the Asian Development Bank and the World Bank, we can manage," he said.

Notable contraction

The Central Bank recently said there was a "notable contraction" in merchandise trade deficit in October 2022, compared to the previous year, even as Sri Lanka's imports continue to exceed exports by millions of dollars. "Exports will probably be coming down because global demand is also going down... and obviously that will impact imports as well."

While Sri Lankan economists contend that the economy is still on a precarious path, the senior official sought to project a more hopeful picture, pitching earnings from tourism and remittances as "additional benefits". Official data showed earnings from tourism crossed over \$1 billion from January to October 2022, while workers' remittances went up to \$3 billion during the period.

he Reserve Bank of India could ill afford to opt for a "premature pause in monetary policy action" as it would prove costly at a time when there was 'stickiness in core inflation', Governor Shaktikanta Das stressed at the Monetary Policy Committee's meeting earlier this month, the minutes show. Private cryptos can hasten next financial crisis, says Das

Press Trust of India MUMBAI

Reserve Bank Governor Shaktikanta Das warned that allowing private cryptocurrencies to grow can precipitate the next financial crisis.

Speaking at an event, Mr. Das also said the government and the central bank have been working in a coordinated manner to tame inflation and the Centre is 'equally serious' about curbing price rise.

On private cryptocur-



rencies such as Bitcoin, Mr. Das reiterated the RBI's demand for a complete ban, saying such instruments do not have any underlying value and are speculative.

"It's a 100% speculative activity, and I would still hold the view that it should be prohibited," he said.

"If you try to regulate it and allow it to grow, please mark my words, the next financial crisis will come from private cryptocurrencies," Mr. Das added.

"Cryptocurrencies have huge inherent risks from macroeconomic and financial stability (perspective) and we have been pointing it out," he said.

Mr. Das added that private cryptocurrencies' valuation has shrunk from \$190 billion to \$140 billion.

Musk says he'll exit as Twitter CEO after finding replacement

Elon Musk said on Tuesday he will step down as chief executive of Twitter after finding a replacement.

"I will resign as CEO as soon as I find someone foolish enough to take the job! After that, I will just run the software & servers teams," Mr. Musk tweeted.

fund to bolster carbon market

India is planning a stabilisation fund to keep prices of credits in its planned carbon market above a certain threshold, ensuring that they remain attractive for investors and that the market succeeds in cutting emissions, two government sources said.

Money in the fund would be used by a market regulator to buy carbon credits if prices fell too low, one of the officials said.

Consistent investor interest in credits and a floor under the price would be



needed as sharp falls in the market could discourage industries from reducing carbon dioxide emissions, that official added.

Operational in 2026

Planning envisages the market becoming fully operational in 2026, covering 37% of the country's emissions, according to slides, seen by Reuters, that the Ministry has shown to stakeholders.

Details would be announced next year, said Samrat Sengupta, vice-president for new businesses and market strategy at carbon offsetter EKI Energy Ltd., which has been briefed by the government.

In creating a carbon market, a country sets limit on emissions and then allocates a corresponding quantity of tradable permits, or credits, to the emitters. The quantity reduces over time.

India may lead in digital tech in 2023, says Tech M

ot all matches are won in the first innings. But very many are lost. It is this threat that Bangladesh has to guard against to prevent a clean sweep when it welcomes India to the Sher-e-Bangla Stadium for the second and final Test from Thursday.

In Chattogram, the visitors were 48 for three in the first innings, only to be let off the hook. Bangladesh then collapsed for 150 in its opening essay to hand India the initiative, which K.L. Rahul & Co. capitalised on to record a thumping 188-run victory.

In contrast to the Zahur Ahmed Chowdhury Stadium wicket, which eased up for batting after a tricky first day, the one in Mirpur is expected to be more spin-friendly.

South African legend Aln Donald, who is the hosts' fast-bowling coach, confirmed the same on match-eve, and even gladdened a few local hearts with the news that skipper Shakib Al Hasan was fit to resume his all-rounder duties.

The 35-year-old bowled just 12 overs of his left-arm spin in the first Test because of a rib injury, and the hope is for him to combine well with the in-form Taijul Islam. The Indian nets, predictably, had a fair share of left-arm spin, with Kuldeep Yadav and a local net bowler feeding the batters enough.

Strong batting line-up

But regardless of the strength of the Bangladesh bowling - which will also be bolstered by speedster Taskin Ahmed's return the Indian batting line-up remains formidable.

That it managed to win the first Test without two of its best batters in Rahul and Virat Kohli getting big runs is enough evidence that there are higher gears it can shift into.

Rohit Sharma's unavailability means Shubman Gill will get a chance to build on his hugely satisfying century, albeit on what is expected to be a more

'I felt hunger for the first time in my life'

Tennis great Boris Becker tearfully recounted the moment the door of his singleoccupancy cell at Britain's notorious Wandsworth prison closed for the first time, speaking publicly after serving eight months for bankruptcy offences.

"It was the loneliest moment I've ever had in life," Becker said in an interview with German broadcaster SAT.1 that aired Tuesday, recalling how hours earlier he had been unable to say farewell to his loved ones before being led downstairs to the courtroom jail.

The three-time Wimbledon champion was sentenced to 30 months in prison in April for illicitly transferring large amounts of money and hiding assets after he was declared bankrupt. Becker would normally have had to serve half of his sentence before being eligible for release, but was released early under a fast-track deportation program for foreign nationals.

Arriving in Wandsworth, the 55-year-old Becker said he feared attacks by other inmates.

"The many films I saw beforehand didn't help," Becker said prison auth-

orities appeared to have tried to ensure his safety, allocating him a single cell and getting three experienced inmates - or "listeners" – to guide him in his new life behind bars.

That included coping with the lack of food, Becker said, as prison fare was largely restricted to rice, potatoes and sauce. "Sunday roasts" consisted of a chicken drumstick, he said.

"I felt hunger for the first time in my life," said Becker.

Violence was a problem, he said, recounting instances at Wandsworth and later at HMP Huntercombe where inmates threatened to harm him until others stepped in.

In November, fellow prisoners organised several cakes for his birthday, Becker said.

"I've never experienced such solidarity in the free world," he said.

Poor treatment meted out to hockey legends at World Cup Trophy tour
